<u> Justice Report –</u>

A detailed written report was given to the Board. Court Clerk Puglisi stated the Court took in \$384.74 for the month of April.

CEO Report -

A detailed written report was given to the Board. Councilman Knapic would like the Code Enforcement Officer to send a letter to the owner of a property on Abbotts Road to clean it up. Supervisor Evans will contact the Code Enforcement Officer and discuss it with him.

<u>Highway Report -</u>

Highway Superintendent Schneider gave a detailed report to the Board. He stated that the Town would need to order signs for the peddler, weight limit, and building permit laws. He will check on the price of the signs and how much writing should be put on the signs. He stated that the current Town wide resigning project is 80% complete and he had to order more post and more signs from the County. Superintendent Schneider stated the Highway Department has been grading roads and digging ditches. He stated that he is waiting on his major project of Slab City Road until the State says what they will allow the PAVE NY extra CHIPS money to be spent on. He stated the County will be closing Lyndon Center Road east of Snyder Road going to Cuba, but he is not sure when they will be closing the road. Councilman Knapic asked about the guardrail on North Center Road that is caving in. Superintendent Schneider stated he will look into fixing it, and that it will be a major project to replace.

Councilman Knapic made a motion to pay Abstract 5 of the General Fund claims 75 thru 88 for \$2,960.58 and Abstract 5 of the Highway Fund, claims 53 thru 65 for \$9,343.19. Councilman Evans seconded the motion. The following motion was ADOPTED
