WHEREAS, the public hearing was properly and legally held by the Town Board; now therefore be it

RESOLVED, That Local Law 2-2016, regulating peddling/vending and soliciting in the Town of Lyndon, is hereby adopted; and be it further

RESOLVED, That Local Law 2-2016, consisting of sections 1-14 and being eight (8) pages in length, take effect upon filing thereof with the New York State Secretary of State.
